Pre-Authorized Debit (PAD) Program Application Woolwich Township Water

BENEFITS OF ENROLLING IN A PAD PLAN

- Payment will be deducted automatically from your bank account on the due date shown on your water bill.
- Pre-authorized payment will save you time, postage costs and penalties for missed payments.
- No charge by the Township for the service, but your financial institution may have a service charge.

PROGRAM DETAILS

- To enroll, please print, complete and mail or fax this application form to the address indicated above along with a **void cheque**.
 - PAD plans are not transferred automatically. Complete a new application if moving within the Township.
 - An administrative fee will be applied to your next bill for payments returned for any reason where a PAD contract exists.
 - At such time as your account is in arrears you will be removed from the PAD program.
 - Penalty and interest will be applied to balances in arrears in accordance with the Township's Penalty and Interest By-law.
 - A new PAD must be received a minimum of 3 days before a billing to be effective for that bill.
 - The Township will mail water bills to ratepayers a minimum of twenty-one (21) days in advance of due dates as pre-notification.
 - **This PAD may be cancelled at any time by written request. This must be received fourteen (14) days prior to the next payment date**
- PAD plans relate to method of payment only. Cancellation of this agreement does not affect your financial obligations.**
