## **TOWNSHIP OF WOOLWICH OFFICIAL PLAN APPROVAL**

The Council of the Township of Woolwich adopted By-law 55-2021 on September 21, 2021 to repeal the previous Woolwich Official Plan (i.e., adopted by By-law 75-2000) and replace it with this Plan.

On June 22, 2022 the Township of Woolwich Official Plan (i.e., this Plan) was approved with modifications and deferrals by the Regional Municipality of Waterloo in accordance with Sections 17 and 21 of the Planning Act, R.S.O. 1990, Chapt. P.13., as amended.
